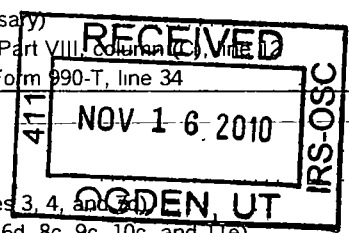

The 10,000 Year Clock Project was conceived by Danny Hillis as a monument to long-term thinking. The design development on the clock began in 01997 and has generated an early prototype, an orrery-like planetary display, and several mechanical and design patents. As the first step toward building the clock, the Foundation has purchase desert mountain land adjoining Great Basin National Park in eastern Nevada.

The Long Now Foundation engages in various projects and programs whose aim is to creatively foster responsibility in the framework of the next 10,000 years. Besides the 10,000 Year Clock and Seminars About Long Term Thinking, these projects include a series of special performing arts events, a museum space open to the public seven days a week, Long Bets, and The Rosetta Project.
